Partially Compliant

This website is partially compliant with the requirements set out in Annex A of the UNI CEI EN 301549 standard, due to the non-compliance cases listed below.

Non-accessible Content

Non-compliant sections, content and functions:

- **C.9.1.1.1:** Some non-text content presented to users does not have an equivalent text alternative serving the same purpose.
